

LICENSE AGREEMENT FOR SHIELD-HIT12A

FOR NON-COMMERCIAL USE ONLY

SHIELD-HIT12A is a Monte Carlo particle transport software code for transport of charged and uncharged particles, optimized for research in particle therapy with ions.

All knowhow and all intellectual property rights, including but not limited to, copyright and trade secrets, relating to SHIELD-HIT12A are owned collectively by:

- The Institute of Nuclear Research, RAS, Moscow, Russia (<http://www.inr.ru/shield>)
- The Aarhus Particle Therapy Group, Aarhus University (<http://www.phys.au.dk/aptg>), and
- Central Denmark Region (Region Midtjylland), Denmark

hereinafter referred to as "the Owners".

Rights of third parties not owned by the Owners are only included in this Agreement if a) the Owners have made a specific statement concerning third party rights being included in this Agreement, and further b) only if the Owners are entitled to make the third party rights a part of this Agreement.

PLEASE NOTE THAT THIS AGREEMENT ONLY ALLOWS FOR USE OF ONE COPY OF THE SOFTWARE. HOWEVER, THE OWNERS ACKNOWLEDGE THE NEED FOR USING THE SOFTWARE IN RESEARCH GROUPS OR IN CLUSTER ENVIRONMENTS WHERE SEVERAL COPIES OF THE SOFTWARE ARE NEEDED. You agree to the following:

BY DOWNLOADING AND/OR USING THE SOFTWARE, YOU (the "Licensee", cf. definition below Section 1) ACCEPT AND AGREE TO THIS LICENSE AGREEMENT, AND AGREE THAT THE FOLLOWING

AGREEMENT FORMS A BINDING LEGAL AGREEMENT (the "Agreement") BETWEEN YOU AND THE OWNERS, AND YOU AGREE TO BE BOUND BY THIS AGREEMENT. ANY DOWNLOAD OR USE OF THE SOFTWARE OR COPIES THEREOF IS SUBJECT TO THIS AGREEMENT. YOU ARE OBLIGED TO STOP USING AND DELETE ANY COPIES OF THE SOFTWARE IF YOU DO NOT AGREE WITH THIS AGREEMENT IN ITS ENTIRETY.

1. **DEFINITIONS**

Term	Definition
Access Credentials	A unique personal login with a unique password for individual access to The Software on the Download Site.
Access Date	Date on which Access Credentials has been made available to the Licensee.
Build Date	Date on which the Software or the Demo-software has been compiled.
Demo-software	The Demo-software is a limited version of the Software.
Download Site	<p>Site referred to from http://www.shieldhit.org/ where the Software and the Demo-software can be obtained. Access to the Software is given after Licensee's login with the Access Credentials.</p> <p>Furthermore, the Download Site is occasionally updated with useful information on the Software (including documentation), references to new builds and references to relevant publications. The Licensee is urged to review the Download Site on a regular basis.</p>
Internal Use	Internal Use shall mean use for Non-Commercial Purposes, within a public funded research institution, research group or the like, or in private, in which the Software is used as a tool for research and development.
Licensee	The person, company or other legal entity who is accepting this Agreement.
Non-Commercial Use/Purpose	Use for non-profit purposes and activities that does not in some sense involve commerce.
Party (or Parties)	Individual (or joint) reference to the Owners or the Licensee.

Term	Definition
Rights	All intellectual property rights and all knowhow, including, but not limited to, copyright, inventions, patents and patent applications, utility models and utility model applications, trademarks and other distinctive marks, semiconductor rights and trade secrets.
Software	<p>A computer program created or made available by the Owners under or relating to the SHIELD-HIT12A project. SHIELD-HIT12A is provided as a binary executable, along with supplementary programs and documentation.</p> <p>The references to "Software" in the Sections of this Agreement will also refer to the Demo-software, unless specific provisions for Demo-software have been stated.</p>

2. GRANT OF LICENSE

2.1 License

- 2.1.1 Subject to the limited rights expressly granted hereunder, the Owners reserve all rights, title and interest in and to the Software, including all Rights. No rights are granted to the Licensee hereunder other than as expressly set forth herein. All rights not expressly granted in this Agreement are reserved by the Owners.
- 2.1.2 The Licensee shall be granted a non-exclusive and non-transferable license to download and use a single copy of the Software (and provided documentation) for Non-Commercial Purposes. The Licensee shall be responsible for handling and storing the Software in such manner that no third party may obtain access thereto unless otherwise is specified in this Agreement or in separate agreement with the Owners.
- 2.1.3 The Software may only be downloaded and otherwise acquired, using the obtained Access Credentials to access the Software on the Download Site after prior acceptance of this Agreement. The Demo-software may be downloaded (without Access Credentials) directly from the Download Site and accessed under the terms of the Agreement.
- 2.1.4 The Software may only be accessed and used if the Software (the copy in question) has been downloaded from the Download Site, unless otherwise is specified in this Agreement or in separate agreement with the Owners.
- 2.1.5 The Licensee is given access to any new versions and builds of the Software on the Download Site during the term of this Agreement (see section 6 regarding term). The Owners are not under any obligation to update the Software, service the Software (including bug-fixes) or provide new versions of the Software.

THIS AGREEMENT WILL BE REPLACED BY THE LICENSE TERMS IN FORCE AT THE TIME IN QUESTION IF THE LICENSEE CHOOSES TO DOWNLOAD ANY UP-DATE, PATCH OR NEW VERSION OF THE SOFTWARE.

2.1.6 Licensee may use the Software for Internal Use only. Any use other use than Non-Commercial Use of the Software, including but not limited to, any commercialisation of the Software or derivatives of the Software or commercialisation of products containing any parts or derivatives of the Software requires a separate license.

2.2 **Restrictions**

2.2.1 Licensee acknowledges that the license extends only to Licensee's use of the features and functionalities of a single copy of the Software (excluding copies made in random access memory etc. needed for installing and running the Software). The Licensee is allowed to remove the Software from a unit/computer and install/use the Software on another unit/computer as long as only one installed and functioning copy exists.

2.2.2 The Demo-software is only intended to give the Licensee an impression of the functions of the Software. The Licensee shall not use the Demo-software for other purposes, including scientific or commercial use.

2.2.3 The Licensee must not (unless to the extent permitted under mandatory law):

2.2.3.1 - use the Software for other purposes than Non-Commercial Purposes;

2.2.3.2 - modify, create, or use derivative works based upon the Software in whole or in part;

2.2.3.3 - copy, frame or mirror any part or content of the Software, except for usage as specified in Section 2.2.1;

2.2.3.4 - distribute the Software or electronic or printed copies of the Software, including, but not limited to, selling, leasing, lending, renting, transferring, sublicensing, or otherwise transfer rights to the Software to third parties unless otherwise is specified in this Agreement or in separate agreement with the Owners;

2.2.3.5 - remove any proprietary notices or labels on or in the Software;

2.2.3.6 - reverse engineer, decompile, translate, or disassemble the Software in whole or in part;

2.2.3.7 - gain access to the source code or in any way use the Software in any other state than executable/binary state,

2.2.3.8 - in any way access the Software in order to (a) build a competitive product or service, or (b) copy any features, information, data, functions or graphics of the Software, which are not intended to be accessible through regular use of the Software;

- 2.2.3.9 - use the Software for illegal or unjustified purposes or uses which are not authorized in this Agreement or other agreements entered into with the Owners;
- 2.2.3.10 - use the Software in any way which may infringe third party rights, including, but not limited to, Rights.
- 2.2.4 Any use in violation of this Section shall immediately terminate Licensee's license to the Software and subject Licensee to liability under Danish law.

3. **PUBLICATION AND DISSEMINATION**

- 3.1 The Licensee shall explicitly acknowledge his/her use of the Software in any publication or communication, scientific or otherwise, relating to such use, by citing the Software SET OF REFERENCES (see Section 13 below) and the copyright (citing the Owners).

4. **SUGGESTIONS**

- 4.1 The Owners shall have a royalty-free, worldwide, irrevocable, perpetual license to use and incorporate into the Software any suggestions, enhancement requests, recommendations or other feedback provided by the Licensee relating to the Software, or any modifications thereof.

5. **WARRANTIES AND LIABILITY**

5.1 **Warranties by the Licensee**

- 5.1.1 The Licensee warrants that the Licensee has validly entered into the Agreement and has the legal power to do so.

5.2 **Disclaimer**

- 5.2.1 THE SOFTWARE IS PROVIDED BY THE OWNERS "AS IS" AND ANY EXPRESS OR IMPLIED WARRANTIES, INCLUDING, BUT NOT LIMITED TO, IMPLIED WARRANTIES OF MERCHANTABILITY, OF SATISFACTORY QUALITY, AND FITNESS FOR A PARTICULAR PURPOSE OR USE ARE DISCLAIMED. THE OWNERS MAKE NO REPRESENTATION THAT THE SOFTWARE AND MODIFICATIONS THEREOF WILL NOT INFRINGE ANY PATENT, COPYRIGHT, TRADE SECRET OR OTHER RIGHTS.

- 5.2.2 THE SOFTWARE IS NOT CERTIFIED FOR CLINICAL PURPOSES INCLUDING ANY FORM OF PATIENT TREATMENT OR OTHER CRITICAL USES.

5.3 **Limitation of liability**

5.3.1 THE OWNERS SHALL HAVE NO LIABILITY FOR DIRECT, INDIRECT, SPECIAL, INCIDENTAL, CONSEQUENTIAL, EXEMPLARY, PUNITIVE OR OTHER DAMAGES OF ANY CHARACTER INCLUDING, WITHOUT LIMITATION, PROCUREMENT OF SUBSTITUTE GOODS OR SERVICES, LOSS OF USE, DATA OR PROFITS, OR BUSINESS INTERRUPTION HOWEVER CAUSED AND ON ANY THEORY OF CONTRACT, WARRANTY, TORT (INCLUDING NEGLIGENCE), PRODUCT LIABILITY OR OTHERWISE, ARISING IN ANY WAY OUT OF THE USE OF THE SOFTWARE, EVEN IF ADVISED OF THE POSSIBILITY OF SUCH DAMAGES, AND THE LICENSEE SHALL HOLD THE OWNERS FREE AND HARMLESS FROM ANY LIABILITY, INCLUDING CLAIMS BY THIRD PARTIES IN RELATION TO SUCH USE.

5.3.2 The Licensee agrees that any liability of the Owners, notwithstanding Sections 5.2.1 and 5.3.1, with respect to any incident arising out of or related to this Agreement (whether in contract or tort or under any other theory of liability) shall not exceed EURO 1,000.

6. **TERM**

6.1 **The Software**

6.1.1 This license commences on the Access Date and allows the Licensee an access to download the Software (and any new versions and builds of the Software (to replace Licensee's current version of the Software) when and if released) on the Download Site, after Licensee has obtained Access Credentials, in accordance with this Agreement until further notice on Download Site. The Owners can at any time decide to limit the period/term in which the Licensee has access to download the Software, including immediate termination of access. The Licensee is allowed to use downloaded versions and builds of the Software in accordance with this Agreement for a period of 2 years from the Build Date of the (downloaded) Software.

6.1.2 This license and the Licensee's right of use in accordance with Section 6.1.1 can be terminated by the Owners with 6 months written notice by the end of a calendar month. The Owners shall review any objection against termination made by the Licensee, however the Owners may decide on termination at their sole discretion. The Licensee agrees that the Owners shall not be liable for any (direct or indirect) loss due to termination in accordance with Sections 6.1.2 and 6.4.1.

6.2 **The Demo-software**

6.2.1 This license comes into force on download of the Demo-software. The Licensee is allowed to use the Demo-software in accordance with this Agreement for a period of 2 years from the Build Date of the Demo-software.

6.2.2 This license and the Licensee's right of use in accordance with Section 6.2.1 can be terminated by the Owners immediately upon written notice, e.g. by e-mail. The Licensee agrees that the Owners shall not be liable for any (direct or indirect) loss due to termination in accordance with Sections 6.2.2 and 6.4.1.

6.3 **Software will automatically stop working**

6.3.1 The Software will become unusable 2 years after the Build Date.

6.4 **Termination for cause**

6.4.1 This license and the Licensee's right of use in accordance with Sections 6.1.1 and 6.2.1 shall terminate with immediate effect and without notice if:

6.4.1.1 - the Licensee fails to comply with any of the terms of this License Agreement,

6.4.1.2 - if the Licensee initiates litigation against any of the Owners with regard to the Software, or

6.4.1.3 - if the Licensee, at the sole opinion of the Owners, is or has been using the Software for other than Non-Commercial Purposes.

8. **SEVERABILITY**

8.1 If any provision of this Agreement is held to be illegal, invalid or unenforceable, (i) such provision shall be deemed amended to achieve the same economic effect to the extent possible as the original provision, and (ii) the legality, validity and enforceability of the remaining provisions of this Agreement shall not be affected or impaired thereby.

9. **WAIVER**

9.1 No term or provision hereof will be considered waived, and no breach excused, unless such waiver or consent is in writing signed on behalf of the party against whom the waiver is asserted. Exceptions to Section 2.1.2 and 2.2.3.4 can be made by the Owners by e-mail or similar written notice. No consent to, or waiver of, a breach by either party, whether express or implied, will constitute consent to, waiver of, or excuse of any other, different or subsequent breach by either party.

10. **ENTIRE AGREEMENT**

- 10.1 The Licensee agrees that this is the entire Agreement between the Licensee and the Owners, and that it supersedes any prior Agreement, whether written or oral, and all other communications between the Owners and the Licensee relating to the subject matter of this Agreement.
- 10.2 The Owners may at their discretion choose to set new license terms for the download and use of any up-date, patch and new versions of the Software.

11. **GOVERNING LAW**

- 11.1 This Agreement shall be governed by the laws of Denmark.

12. **JURISDICTION**

- 12.1 Any dispute arising out of or in connection with this Agreement, including any disputes regarding the existence, validity or termination thereof, shall be settled by arbitration arranged by The Danish Institute of Arbitration in accordance with the rules of simplified procedure adopted by The Danish Institute of Arbitration and in force at the time when such proceedings are commenced. The Owners may, however, alternatively and at their discretion choose to:
- commence proceedings arising out of or in connection with this Agreement at any Danish court of law or at any court within the Licensee's jurisdiction,
 - have the licensee commence proceedings arising out of or in connection with this Agreement at any Danish court of law or at any court within the Licensee's jurisdiction, if the Licensee decide to commence proceedings,
- 12.2 The Licensee shall prior to any commencement of proceedings give the Owners a 10 day notice for the Owners to decide the venue and jurisdiction for proceedings cf. section 12.1.

13. **SET OF REFERENCES**
